This matter having come before the Kentucky Board for Marriage and Family Therapists (hereinafter referred to as “the Board”) on May13, 2010, and the Board having considered the record along with the Findings of Fact, Conclusions of Law and Recommended Order, filed thereto and pursuant to KRS 13B.120(1), hereby ORDERS as follows:

(1) The Findings of Fact and Conclusions of Law issued by the Hearing Panel on or about April 8, 2010, supports a violation of KRS 335.348(1)(g), specifically 201 KAR 32:050 §2(d) and is hereby **ADOPTED**; and

(2) The Recommended Order is hereby **MODIFIED** to the following:

a) **Seven (7) months probation beginning the date of the Final Order, with the condition to complete six (6) one-hour consultations with a Board selected marriage and family therapy professional, at Ms. Crawford’s expense, to improve in the following areas:**

- 1. Documentation**
- 2. Progress notes**
- 3. Confidentiality**

4. Informed Consent

5. Waivers


